Resolution No. 3-2016, authorizing the Authority to designate Harrisburg Housing Authority and its development entity, First Uptown, LP as Designated Developer of 2145 Turner Street; 2150, 2230, 2232, 2240, 2284, 2290, 2292, 2301, 2302, 2303, 2304, 2305, 2306, 2307, 2309, 2311, 2313, 2315, 2317, 2319, 2321, 2323, 2325, 2327 and 2329 N. 6<sup>th</sup> Street; and 600, 602, 604, 606, 616, 618, 632, 634, 640, 642, 644, 646, 648 Woodbine Street to be developed as single family residential homes. Mr. Davis added that in total it is 40 lots that HRA owns and the proposal is along with property that the Authority doesn't own, which is the Hudson Building at the corner of 6<sup>th</sup> and Maclay Streets. HRA's sites would deliver single family rentals to the project of approximately thirty. Mr. Davis pointed out that
