RESOLUTION NO. 14-2021, authorizing the Authority to approve the sale of three (3) vacant lots at 442, 444, and 446 S. 14th Street to John Everett for the use of a residential accessary yard to his single-family house located at 1318 Swatara Street. Mr. Leppo moved to approve; second by Ms. Brown. The motion passed unanimously.

RESOLUTION NO. 15-2021, authorizing the Authority to approve a four (4) year Lease with The Worship Academy School of the Arts for two (2) Suites, 207 and 209 located at the Harrisburg Transportation Center. Ms. Brown moved to approve; second by Mr. Leppo. The motion passed unanimously.
