RESOLUTION NO. 12-2018 Harrisburg Redevelopment Authority

WHEREAS, Tri-County Regional Planning (TCRP) has awarded a \$40,000 Regional Connections grant to the City of Harrisburg (City); and

WHEREAS, the City must provide \$10,000 cash match for this grant; and

WHEREAS, the City has requested that, on its behalf, the Redevelopment Authority of the City of Harrisburg (Authority) use the total of \$50,000 towards planning work that will enhance and complement the Authority's EPA Area-Wide Planning activity in South Allison Hill; and

WHEREAS, the Authority is willing to execute the Grant Agreement with TCRP for the \$40,000 Regional Connections Grant on behalf of the City, provided that the City delivers the required \$10,000 cash match; and

WHEREAS, the City's match funds will be included in the City Engineer's 2019 budget, and the Authority is willing to use its funds until the City is able to reimburse the Authority in 2019.

NOW, THEREFORE, BE IT RESOLVED that the Redevelopment Authority of the City of Harrisburg hereby authorizes and approves the execution of a Grant Agreement with Tri-County Regional Planning in the amount of \$40,000, so long as the City of Harrisburg delivers to the Authority the required \$10,000 match.

BE IT FURTHER RESOLVED, that the Authority approves temporarily using its funds as bridge funding for the City's matching funds, if necessary.
